| Will you pay less if you use a network provider? | Yes. Excluded Services & Other Covered Services:

- Routine eye care (Adult) - 1 routine eye exam/calendar year.

Does this plan meet Minimum Value Standards? Yes.

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
