FINAL NOTICE: PAYMENT DUE MHPNJ EMPLOYER LETTER

October 26, 2021

**Re: Affiliated Physicians & Employers Master Trust (“APEMT”)
and Members Health Plan New Jersey (“MHPNJ”),**

Dear Employer/Member:

We write to you with regard to the notice of assessment addressed to your company and the several letters with regard to your failure to pay same. If you have made your payment in full or already entered into a payment plan, please disregard this letter.

For your benefit, attached hereto are the relevant provisions of the New Jersey MEWA Statute, which governs APEMT/MHPNJ. You will note that the Statute specifically provides for the manner in which the assessments are calculated. You will note that your firm’s assessment is “individual, several and proportionate”. If any member does not pay, the remaining members shall be required to pay that assessment.

Significantly, the Statute specifically requires APEMT/MHPNJ, acting on behalf of all of the members who paid the additional assessment, to take appropriate legal action to recover the assessment from any member who fails to pay. Additionally, if suit is brought, APEMT/MHPNJ is not only entitled to seek collection of the assessment, but all costs and expenses in collecting the assessment.

Please be advised that more than half of the total assessment against the members has been paid by member/employers without the institution of suit. If we are required to institute suit against your firm, we will seek the award of our counsel fees and costs, pursuant to the MEWA Statute.

We are providing you with a last opportunity to pay the assessment, before the matter is referred to outside counsel for the institution of suit against you. **If you do not make payment or contact us to enter into a short payment plan, the assessment against you will be referred to counsel on or about November 5, 2021.** For a payment plan request or credit card payment, please email us at MEWAbilling@concordmgt.com.
