Re: Affiliated Physicians and Employers Master Trust (“APEMT”) and
Members Health Plan New Jersey (“MHPNJ”)
Plan Financial Deficiency

Dear Employer:

This letter is to inform you that our records indicate that your group still remains active with Members Health Plan New Jersey (“MHPNJ”). We have asked all groups to terminate their coverage on multiple occasions and we would encourage you to do so no later than October 31, 2021. Claims are currently being suspended and are not being paid by Aetna at this time.

On August 25, 2021, we sent a communication to you indicating that we may be forced to impose further rate increases for the groups remaining enrolled in the Trust. **This letter will serve as notice of an additional rate increase of 24% (for a total increase of 50% from rates that were in effect on July 1, 2021) that will go into effect on November 1, 2021.**

To avoid this new rate increase, please terminate your coverage no later than October 31, 2021. To terminate your coverage, please submit your completed **Health Plan Group Termination Form** via email to the Trust at MEWAenrollment@concordmgt.com.
